Positive Outcomes for Orphans (POFO): HIV Risk as Young Adults

This study builds on the previous POFO longitudinal study of orphaned and separated children (OSC) across 4 low income countries. Up to 14 years of data will be used to develop models that identify early those OSC at highest risk for HIV infection as young adults. A new sample of OSC from each study site will allow for the proper weighting of the original POFO cohort to ensure the relevance of its outcomes to today's population of OSC. The study will use Discrete Choice Experiments (DCEs) to identify how preferences for HIV prevention programs differ by site and gender. Results may be used to develop targeted HIV prevention programs, while methods can be applied to make programs locally acceptable and thus more effective.
